# II. Progress Report

Line Landfill Certification

• Certification was issued by the State of Vermont in late November. It includes the waiver of the liner and allows Omya to extend to the south of the current tailings location beginning in 2018. The certification will expire in 2023.

### Hogback Quarry Blasting Update

• Omya submitted the Act 250 permit application in December and a hearing date was set for late January. Prior to the hearing date additional neighbors requested to be notified of the changes. This postponed the hearing date. The permit application will be resubmitted on February 19 and a new hearing date will be set.

## Odor

• One odor concern in 2015. Omya was not able to fully track down the source at that time and the odor did not return.

### <u>Noise</u>

• There were 5 noise concerns in 2015. The noise was traced back to worn packing within the silencers on our dryers. Omya has updated the frequency of our preventative maintenance (PM) schedule again and have implemented a program to manage these PM's and catch the silencers before they become ineffective.

## Lost Trucks

- Omya continues to focus on trucks coming into the plant on posted roads.
- There has been a reduction in trucks from 2014 to 2015.
- Omya continues to send letters & invoices to customers and carriers.
- Omya continues to contract with the Pittsford Police and Rutland Sheriff's departments to patrol roads on Whipple Hollow Road and West Creek Road.
- Omya needs to replace / update signs in Proctor.

### **Vibrations**

• There were 3 vibration concerns from quarry blasting activities in 2015 - two from the Middlebury Quarry and one from the Hogback Quarry. All concerns were addressed.

### LNG and Safety Training

- Omya continues to work with the Pittsford fire department on LNG safety training.
- In addition, Omya will be working with the local fire department on confined space evacuation drills / exercises.

### III. New Ideas / Topics

- It was asked if Omya could bring stone pieces to the library and do a show-and-tell for the kids.
- There was a question about the road washing last summer / fall. The roads seemed dustier than usual. Omya will be focusing on implementing improvements for washing the roads on-site which should reduce dust tracked out to public roads. Omya will also contract with a new vendor for the road washing.
