## Omya implements further surcharges on Calcium Carbonate products in Europe

Oftringen (Switzerland), August 29, 2022. Omya announces additional surcharges on its Calcium Carbonate products in Europe with immediate effect.

European electricity and gas prices have again reached record highs due to disruption and uncertainty impacting the energy markets.

Several key drivers continue to heavily influence power prices.

Gas deliveries through Nord Stream 1 remain at low levels with flows further reduced due to technical issues and maintenance operations. Moreover, gas supply from Russia through other transport routes have not increased to compensate the Nord Stream flows.

Weather conditions with above normal high temperature, as well as the combination of low generation from the nuclear fleet in France and the low hydro levels in Europe are moving power prices to unexpected levels. More generally, fear of energy non-availability and/or gas curtailment have a major influence on these inflationary trends.

Omya is highly exposed to this unprecedented cost escalation.

Furthermore, inflation continues to increase in Europe, triggering cost development on all other production, logistics and service parameters. The magnitude of these impacts is out of Omya's control, cannot be absorbed and requires implementation of additional temporary surcharges with immediate effect. They will be adjusted according to the ongoing cost developments and canceled as soon as the situation allows.
